4. FIRST-AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. If possible contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain. Dispose of waste according to the applicable local and national regulations. 7. HANDLING AND STORAGE

Precautions for Safe Handling

Avoid inhalation of vapours and mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Maintain high standards of personal hygiene i.e. Washing hands prior to eating, drinking, smoking or using toilet facilities.

13. DISPOSAL CONSIDERATIONS

Disposal considerations

Product Disposal:

Product wastes are controlled wastes and should be disposed of in accordance with all applicable local and national regulations. This product can be disposed through a licensed commercial waste collection service. In this specific case the product is water-based and therefore, after further dilution to render it non-combustible, can be sent through a Waste Water Treatment Plant, and after treatment can be discharged into environment through the sewerage or drainage systems as authorized.

Personal protective clothing and equipment as specified in Section 8 of this SDS must be worn during handling and disposal of this product. The ventilation requirements as specified in the same section must also be followed, and the precautions given in Section 7 of this SDS regarding handling must also be followed.

Do not dispose into the sewerage system. Do not discharge into drains or watercourses or dispose where ground or surface waters may be affected.
